No.2177 (C) of 2006 filed by Sri Khagendranath Jena and others -Vrs- State of Orissa and others.

On promotion to OAS (Supertime Scale), Sri Dillip Kumar Bihara, Deputy Secretary to Government, W & C.D. Department is allowed to continue as joint Secretary to Government in W & C.D. Department.


