No. ID-42/2009/ **15853** /Gen, Sri Muralidhar Palai, OAS-I (Senior Branch) is notionally promoted to the rank of OAS (Supertime Scale) on adhoc basis w.e.f. 16.09.2009 i.e., the date of promotion of his immediate junior Sri Mahendra Kumar Rath, to the rank of OAS (Supertime) vide G.A.Deptt. Notification No. 19228/Gen date 16.09.2009 carrying scale of pay in pay band 03 i.e Rs.15,600-39,100/- + Grade pay of Rs.7, 600/- per month as revised under ORSP Rules, 2008 for a period not exceeding one year or till retirement or receipt of recommendation of O.P.S.C. is received, whichever is earlier without prejudice to the claim of others. His pay shall be notionally fixed in the promotional grade w.e.f promotion of his junior ie. 16.09.2009.

On notional promotion Sri Palai shall not be entitled to arrear financial benefits for the period for which he has not actually worked in the rank of Joint Secretary. Inter-se seniority of Sri Palai is provisionally fixed below Sri Mukund Kissan and above Sri Mahendra Kumar Rath in the rank of OAS (Supertime Scale).

The promotion is subject to out come of OJC No.5922/2000 (Manmohan Mishra -Vrs- State), OJC No.5921/2000 (Durga Prasad Behera -Vrs- State), OJC No.7798/2000 (State -Vrs- Gahadu Mirdha and others), pending in the Hon'ble High Court of Orissa and also subject to out come of O.A. No.2177 (C) of 2006 filed by Sri Khagendranath Jena and others -Vrs- State of Orissa and others.

On promotion to OAS (Supertime Scale), Sri Muralidhar Palai, A.D.M., Khurda is allowed to continue as A.D.M., Khurda.


