No.ID-04/2010/16449 Gen, Promotion of the following OAS Officers from OAS-I (Junior Branch) to OAS-I (Senior Branch) is here by antedated to the date of appointment of their immediate juniors in OAS-I (SB) grade on adhoc basis, in the scale of pay of Rs.10,000 – 325 – 15,200/- in pre-revised scale for a period not exceeding one year or till the recommendation of the OPSC is received or until further orders whichever is earlier without prejudice to the claim of others.

2. These adhoc promotions are subject to final outcome of relevant cases pending before the Hon'ble OAT, High Court and the Apex Court.
