

OFFICE ORDER

Bhubaneswar dated the **26th April,2014**

No.SER1-IAS-28/2014- **12408** /AIS.I.,The Government of India, Ministry of Finance, Department of Expenditure have issued orders regarding payment of one additional dose of Dearness Allowance i.e. from the existing rate of 90% to 100% with effect from 01.01.2014 to all Central Government Employees vide their Office Memorandum No.1/1/2014-E.II(B) dtd.27.03.2014. In view of the provisions contained in Rule 3 of the All India Services (Dearness Allowance) Rules, 1972, Members of All India Services are entitled to get the Dearness Allowance at the following revised rates as specified in the above cited Office Memorandum of Government of India, Ministry of Finance. The State Government in Finance Department vide their Office Memorandum No. 13884/F dtd. 26.04.2014 have released this additional dose of D.A. in favour of State Government employees.

5. The State Government have decided that the additional dose of 10% Dearness Allowances on pay and Grade Pay taken together shall be released in favour of the Members of All India Services working in connection with the affairs of the State Government w.e.f. 01.01.2014 and shall be drawn in cash in the pay bill of April,2014 payable in May,2014 and onwards. Arrears of this enhanced D.A. from the month of January,2014 to March,2014 shall not be drawn before the date of disbursement of salary of April,2014.

01.01.2014	100% on Pay & G.P.


3. This additional dose of D.A. shall be applicable to the members of All India Services, who were in service on the 1st January,2014.
