No.GAD-SER2-ID-0025-2015-11554/SCS. **Shri Batakrushana Dehury, OAS (Supertime Scale)** is promoted to the rank of Superior Administrative Grade in OAS on adhoc basis carrying Pay Band-4 in the scale of pay of Rs.37,400 – 67,000/- + Grade Pay of Rs.8,800/-P.M. for a period not exceeding one year or till receipt of recommendation of OPSC or till their retirement, whichever is earlier without prejudice to the claim of others.

This promotion is subject to final orders of the Hon'ble Apex Court in SLP(C) No.35608-35610 (Gahadu Mirdha-Vs.- State of Odisha and others) and other related cases.

2. According to para-6 of G.A Department Memorandum No.3928 dtd.18.02.1994 Shri Dehury is promoted to the Grade of OAS (SAG) on conditional basis. In case the sealed covers of the officers senior to him is opened and found suitable for promotion to the next higher grade, the officer concerned shall be reverted back to his previous grade.


3. On promotion to OAS (SAG) Shri Batakrushna Dehury is allowed to continue as PD, DRDA, Bargarh.


