Whereas the deferred meeting of the Screening Committee for promotion to the Grade of Chief Conservator of Forests in the Super Timescale of IFS was convened on 28.07.2009 for consideration of the cases of eligible IFS officers whose cases were deferred during the Screening Committee Meeting held on 17.3.2009.

And whereas the findings of the Screening Committee in respect of Dr. Dambaru Sahoo, IFS (RR-83) were kept in "Sealed cover" as per the Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training Circular No.20011/12/92-AIS (II) dtd.8.10.1993 readwith Government of India, Ministry of Environment & Forests letter No.20019/01/2000-IFS(II) dtd. 22.12.2000 in view of the pendency of Disciplinary Proceedings initiated against Dr. Sahoo vide Forest & Environment Department Memorandum No. 427/FE dtd. 06.01.2007.

And whereas, the Disciplinary Proceeding initiated against Dr. Dambaru Sahoo, IFS, Conservator of Forests(Working Plan), O/O PCCF, Bhubaneswar has been dropped vide Forest & Environment Department Office Order No. 15726/F&E dtd. 11.09.2009.

And whereas the Sealed Cover containing the findings of the Screening Committee which met on 28.7.2009 in respect of Dr. Dambaru Sahoo, IFS was opened and he was found 'fit' for promotion to the grade of Chief Conservator of Forests in the Supertime Scale of IFS.

Now therefore, Government, after careful consideration have been pleased to appoint Dr. Dambaru Sahoo, IFS(RR-83), Conservator of Forests(Working Plan), O/O PCCF, Bhubaneswar to the Grade of Chief Conservator of Forests in the Super Time Scale of IFS w.e.f. 05.05.2009 i.e. the date his next junior Dr. Debabrata Swain, IFS(RR-1984) was promoted to such grade vide G.A. Department Notification No.9607/AIS.I, dated 05.05.2009.


