RESOLUTION

The 3rd August, 2010

Subject – Promotion of Group ‘D’ employees to Group ‘C’ Posts

General Administration Department Resolution No.2196., dated 29.01.1997 lays down the provisions for regulating promotion of group "D" employees to Group "C" posts.

2. As per Para. 3 of the abovesaid resolution, Group "D" employees working in the highest Group "D" posts after completion of a minimum of 3 years of service in the said posts were eligible for promotion to Group "C" services/posts like Record Supplier, Treasury Sarkar etc., filled up by promotion only.

3. Similarly, as per Para. 4 of the aforesaid resolution, Group "C" employees holding the above posts were eligible for promotion to the next higher posts like Junior Grade Diarists, Junior Grade Recorder etc., after completion of at least 5 years of service in Group "C" posts.

4. It has come to the notice of Government that promotional posts like Record Supplier/Treasury Sarkar etc.,(Group "C") and Junior Grade Diarist/Junior Grade Recorder etc.(Group "C") remain unfilled due to non-availability of suitable persons for promotion due the experience criteria laid down in the resolution referred to above. Various departments of Government are also coming up with proposals seeking relaxation of the experience criteria so as to enable them to fill up the promotional posts. The process sometimes consume a lot of time not only affecting efficient functioning of the office but also causing some Group "D" employees to retire before getting the opportunity of promotion.

5. Therefore, Government after careful consideration have been pleased to reduce the eligibility criteria of 3 years and 5 years appearing in Para. 3 and 4 of the General Administration Department Resolution No.2196., dated the 29th January,1997 to 2 years and 3 years respectively.

6. All other provisions of the General Administration Department Resolution No.2196/Gen., dated the 29th January,1997 will remain unchanged.

7. This will come into force with effect from the date of issue of this resolution.

ORDER

Ordered that the Resolution be published in the Extraordinary issue of the *Orissa Gazette* for general information. Ordered also that copies of the Resolution be forwarded to all Departments of Government / all Heads of Departments / all Collectors / Registrar, Orissa High Court / Registrar, Orissa Administrative Tribunal / Special Secretary, Orissa Public Service Commission / Secretary, Orissa Staff Selection Commission.
