
No.GAD-SER2-RB-0002-2021- 15414 /Gen. In exercise of the powers conferred by clause (3) of article 166 of the Constitution of India, the Governor of Odisha hereby makes the following amendment to the Odisha Government Rules of Business, namely:-

Amendment

1. In the First Schedule to the Odisha Government Rules of Business, (hereinafter referred to as the said schedule), in serial No.XI, relating to the Department "Industries", the item No.1 "Industrial Development Corporation of Odisha Ltd.", appearing under the State Subjects, against Branch No.5 "Corporations / Boards / Societies", shall be omitted.
2. In the said Schedule, in Serial No.XII, relating to the Department "Steel and Mines", after item No.8 appearing under the "State Subjects" against Branch No.1 "Mining", the following item shall be inserted, namely: -

"9. Industrial Development Corporation of Odisha Ltd."
