Notification

Bhubaneswar dated the 29th July , 2021

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Civil Services (Criteria for promotion) Rules, 1992, namely:—


1. Short title and commencement.— (1) These rules may be called the Odisha Civil Services (Criteria for Promotion) Amendment Rules, 2021.

(2) They shall be deemed to have been come into force with effect from the 30th December, 2020.

2. In the Odisha Civil Services (Criteria for Promotion) Rules, 1992, in rule 3, after the proviso to clause (c), the following proviso shall be inserted, namely: —

“Provided further that recording of annual Confidential Character Rolls (C.C.Rs) in respect of Group-‘C’ employees in the prescribed format by their higher authorities shall not be required for consideration of promotion, instead, the authorities under whom the employees have worked during the year shall assess the performance of the Group-‘C’ employees and record a remark in the HRMS system as “fit for shouldering higher responsibility” or “not fit for shouldering higher responsibility” which shall be taken into consideration and be placed before the DPC for consideration of promotion.”
