In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules to amend the Odisha Heads of Department (Method of Recruitment and Conditions of Service of Establishment Officers, Administrative Officers and Senior Administrative Officers in the Office of the Heads of Departments) Common Cadre Rules, 2019, namely:-

- 1. **Short title and commencement.**—(1) These rules may be called the Odisha Heads of Department (Method of Recruitment and Conditions of Service of Establishment Officers, Administrative Officers and Senior Administrative Officers in the Office of the Heads of Departments) Common Cadre (Amendment) Rules, 2021.
- (2) They shall come into force on the date of their publication in the *Odisha Gazette*.
- 2. In the Odisha Heads of Department (Method of Recruitment and Conditions of Service of Establishment Officers, Administrative Officers and Senior Administrative Officers in the Office of the Heads of Departments) Common Cadre Rules, 2019, in rule 6, for sub-rules (2) and (3), the following sub-rules shall be substituted, namely:—
- "(2) Appointment to the post of Administrative Officer shall be made on promotion from amongst the Establishment Officer on the basis of merit and suitability with due regard to seniority.
- (3) Appointment to the post of Senior Administrative Officer shall be made on promotion from amongst the Administrative Officer on the basis of merit and suitability with due regard to seniority".
