### NOTIFICATION

The 8th January, 2015

No. 483-GAD-SC-RULES-0043/2014/Gen.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Civil Services (Criteria for Selection for Appointment including Promotion) Rules, 2003, namely :-

1. (1) These rules may be called the Odisha Civil Services (Criteria for Selection for Appointment including Promotion), Amendment Rules, 2014.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Odisha Civil Services (Criteria for Selection for Appointment including Promotion) Rules, 2003, (hereinafter referred to as the said rules), in rule-2, after clause (b) the following clause shall be inserted, namely:-

“(b-1) “Recruiting Agency” means the Commission, Odisha Staff Selection Commission, Odisha Subordinate Staff Selection Commission or Selection Committee, as the case may be;”.

3. In the said rules, in rule-3 after the words and expression “Odisha Staff Selection Commission” and before the word “Selection”, the following words and expression shall be inserted, namely:—

“Odisha Subordinate Staff Selection Commission”.

4. In the said rules, after rule-3, the following rules shall be inserted, namely:—

**“3-A. Plan of Recruitment:** In case proposals from appropriate authority for filling up of the vacant posts are not received in due time, the Recruiting Agencies shall initiate recruitment every year for each cadre basing on the anticipated vacancies based on retirement, creation of posts or otherwise and promotion as per the provisions of respective recruitment rules on obtaining information from the Co-ordination Committee constituted under rule 3B of this rule.

**3-B. Constitution of Co-ordination Committee:** (1) There shall be constituted a Co-ordination Committee to ascertain the number of vacant posts cadrewise for recruitment, consisting of the following members, namely:—

(2) The General Administration Department shall convene and Co-ordinate the meeting.

(3) The Co-ordination Committee shall sit every year for the purpose mentioned in sub-rule(1).

**3-C. Clubbing of posts:** Posts with similar qualifications may be grouped together to conduct common recruitment examination.

**3-D. Validity of Merit List:** (1) The Merit List shall remain valid for one year from the date of approval by the competent authorities.

(2) The Recruiting Agency may furnish a supplementary List of candidates from the respective categories against which the candidates recommended did not join during the year in which the recruitment is made after receiving the requisition from the appointing authorities to that effect.”
