Notification

Bhubaneswar dated the 01st December, 2020

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Civil Services (Criteria for promotion) Rules, 1992, namely:—

1. Short title and commencement.— (1) These rules may be called the Odisha Civil Services (Criteria for Promotion) Amendment Rules, 2020.

(2) They shall come into force on the date of their publication in the Odisha Gazette.

2. In the Odisha Civil Services (Criteria for Promotion) Rules, 1992, in rule-3,—

(i) in clause (c),—

(a) in the proviso, for the words, "three years" and "five years", the figure and word, "36 months" and "60 months" respectively shall be substituted.

(b) NOTE II, along with contents thereof shall be omitted.

(ii) After clause (c), the following clauses shall be inserted, namely: —

"(d) The PAR, the vigilance reports, papers relating to departmental action and other confidential reports shall be forwarded online to avoid delay:

Provided that above reports shall not be required in respect of Group-'D' employees.

(e) The selection for the year shall be held during the month of November taking into account the residency period as prescribed under the relevant Recruitment Rules and the Select List shall be prepared during the month of December of the preceding year. "
