## NOTIFICATION

Bhubaneswar dated the 27th October, 2021

In exercise of the powers conferred by proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Group "C" and Group "D" posts (contractual appointment) Rules, 2013; namely:—

- 1. **Short title and Commencement.** (1) These rules may be called the Odisha Group "C" and Group "D" posts (contractual appointment) Amendment Rules, 2021.
  - (2) They shall come into force on the date of their publication in the Odisha Gazette.
- 2. In the Odisha Group "C" and Group "D" posts (contractual appointment) Rules, 2013 (here-in-after referred to as the said rules), in rule 2, in sub-rule (1), after clause (a), the following clause shall be inserted, namely:—
- "(a-1) "Initial Appointees" means the persons appointed to any Group C and Group D posts by way of direct recruitment made under rule 5;"
  - 3. In the said rules, in rule 9.—
- (i) in the heading, for the words "Contractual Employees", the words "Initial Appointees" shall be substituted.
  - (ii) for sub-rule (1), the following sub-rule shall be substituted, namely:—
- "(1) **Tenure of Initial Appointees:** Persons appointed under sub-rule (2) of rule 5, shall continue as Initial Appointees for a period of six years, which shall be reckoned from the date of their appointment under rule 5."
  - (iii) for sub-rule (2), the following sub-rule shall be substituted, namely:—
- "(2) **Remuneration:** During the period of initial appointment, they shall draw monthly remuneration at the rates prescribed in the Annexure appended to these rules as applicable to their number of completed years of service."



- (iv) for sub-rule (3), the following sub-rule shall be substituted, namely:—
- "(3) **Annual Increase of Remuneration:** Subject to satisfactory performance, the remuneration of initial appointees shall be enhanced as per slabs prescribed under the Annexure appended to these rules on completion of each year of service."
  - (v) for sub-rule (4), the following sub-rule shall be substituted, namely:—
- "(4) **Allowances:** They shall not be entitled to D.A., HRA, and other allowances except RCM during the period of initial appointment."
- 4. In the said rules, for the Annexure appended to the Rules, the following Annexure shall be substituted, namely:—
