NOTIFICATION

Bhubaneswar, dated the 16 November, 2019.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Odisha hereby makes the following rules further to amend the Odisha Ministerial Services (Method of Recruitment and Conditions of Service of Junior Assistants, Senior Assistants and Section Officers in the District Offices and Offices Sub-ordinate thereto) Rules, 2019; namely:-

1. Short title and commencement- (1) These rules may be called the Odisha Ministerial Services (Method of Recruitment and Conditions of Service of Junior Assistants, Senior Assistants and Section Officers in the District Offices and Offices Sub-ordinate thereto) Amendment Rules, 2019.

(2) They shall come into force on the date of their publication in the Odisha Gazette.

2. In the Odisha Ministerial Services (Method of Recruitment and Conditions of Service of Junior Assistants, Senior Assistants and Section Officers in the District Offices and Offices Sub-ordinate thereto) Rules, 2019, in rule 3, after clause (c), the following proviso shall be added , namely:-

“Provided that, the Junior Assistants and Senior Assistants who are posted in Revenue Organisation or services placed to other Departments against posts sanctioned by Revenue Department shall be designated as Junior Revenue Assistant and Senior Revenue Assistant respectively”.
