NOTIFICATION

No.13387-SC/5-01/2011/Gen.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Orissa is pleased to make the following rules further to amend the Orissa Civil Service (Combined Competitive Recruitment Examination) Rules, 1991, namely:—

- **1.** (1) These rules may be called the Orissa Civil Service (Combined Competitive Recruitment Examination) Amendment Rules, 2011.
 - (2) They shall come into force on the date of their publication in the *Orissa Gazette*.
- **2.** In the Orissa Civil Service (Combined Competitive Recruitment Examination) Rules, 1991(hereinafter referred to as the said rules), in rule 5
 - (i) in sub-rule (1), clause "(ii)" shall be substituted by the following clause, namely:—
 - "(ii) Knowledge in Oriya: He must be able to read, write and speak Oriya; and have-
 - (a) passed Middle School Examination with Oriya as a language subject; or
 - (b) passed High School Certificate or equivalent examination with Oriya as medium of examination in non-language subject; or
 - (c) passed in Oriya as a language subject in the final examination of Class-VII from a school or educational institution recognized by the Government of Orissa or the Central Government; or
 - (d) passed a test in Oriya in Middle English School Standard conducted by the School & Mass Education Department of the Government of Orissa".
- (ii) in sub-rule (2), clause (i) along with the proviso thereunder, shall be substituted by the following, namely:—
 - "(i) Age Limits: A candidate must have attained the age of 21 years and must not be above the age of 32 years on the first day of January of the year in which the advertisement is made:

Provided that the Upper Age Limit in respect of reserved categories of candidates shall be relaxed for the respective categories in accordance with the provisions of the Orissa Civil Service (Fixation of Upper Age Limit) Rules, 1989."

- **3.** In the said rules, in rule 19(A), in clause (i), the words "and in that case the proviso to clause (i) of sub-rule (2) of rule 5 shall apply", shall be omitted.
- **4.** In the said rules, the SCHEDULE-I shall be substituted by the following Schedule, namely:—
