NOTIFICATION

Bhubaneswar, the 9th June, 2021.

No.GAD-SC-RULES-0009-2021- 15318 /Gen. In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Ex-servicemen (Recruitment to State Civil Services and Posts) Rules, 1985; namely:-

1. Short title and commencement.- (1) These rules may be called the Odisha Ex-servicemen (Recruitment to State Civil Services and Posts) Amendment Rules, 2021.

(2) They shall come into force on the date of their publication in the Odisha Gazette.

2. In the Odisha Ex-servicemen (Recruitment to State Civil Services and Posts) Rules, 1985 (herein after called the said rules), in rule 4, in sub-rule(1), the words and comma "as per the roster points shown in the Schedule appended to these rules," appearing after the words "Ex-servicemen" and before the words "Different Head of Offices" shall be omitted.

3. In the said rules, after rule 5, the following proviso shall be inserted, namely:-

" provided that those ex-servicemen who have already secured regular employment under the State Government in civil posts and services would be permitted the benefit of age relaxation as admissible for ex-servicemen for securing another employment in any higher post or service under the State Government but such candidates shall not be eligible for the benefit of reservation, if any, for ex-servicemen in the State Government"

4. In the said rules, the "SCHEDULE" appended thereto shall be omitted.
