BRIEFS OF THE FIELD ESTABLISHMENT SECTION

1. **Odisha Public Service Commission (OPSC)**:- OPSC is a Constitutional body consists of a Chairman and 5 Members. At present four Members are in position. OPSC is conducting the recruitment for different Group-A & Group-B (State Cadre) posts of the various Departments under the Government of Odisha.
2. **Odisha Staff Selection Commission (OSSC)**:- Odisha Staff Selection Commission is conducting all the recruitment examination of State Cadre Group-B & C post. It consists of a Chairman & three Members. At present one Chairman and one Member are in position.
3. **Odisha Sub-ordinate Staff Selection Commission (OSSSC)**:- The OSSSC is conducting recruitment examination of District Cadre Group-B & C posts. It consists of a Chairman and two Members. At present the Commissioner-cum-Secretary to Government, Higher Education Department is acting as Chairman of OSSSC and two Member is in position.
4. **Gopabandhu Academy of Administration (GAA)**:- GAA is the apex Training Institute of the State. It imparts induction training to IAS, IES, IFS and OAS officers. Further, it imparts short term training to other State Government officers in different subjects. Government of India and State Government are sanctioning funds for various training programme.
5. **Odisha Administrative Tribunal (OAT)** :- DoPT, Gol have notified abolition of Odisha Administrative Tribunal vide Notification No. GSR 552 dated 02.08.2019.

No. 7681—GAD-FE-OSSC-0001/2016-Gen.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Staff Selection Commission (Method of Recruitment and Conditions of Service of Chairman and Members) Rules, 1995, namely :-

1. Short title and commencement.—(1) These rules may be called the Odisha Staff Selection Commission (Method of Recruitment and Conditions of Service of Chairman and Members) Amendment Rules, 2020.

(2) They shall be deemed to have come into force on the 1st day of January, 2016.

2. In the Odisha Staff Selection Commission (Method of Recruitment and Conditions of Service of Chairman and Members) Rules, 1995 (here-in-after referred to as said rules) in rule 2, for clause (d), the following clause shall be substituted, namely:—

(d) "Last Pay" means the pay drawn last or the pay fixed notionally immediately before retirement in respect of the person concerned, as the case may be, or the minimum of the corresponding revised scales of pay, if any, of the post last held by him whichever is higher.

3. In the said rules, in rule 5, for the first proviso to sub-rule (1) the following proviso shall be substituted, namely:—

"Provided that if a person who after retirement from Government service, is appointed as Chairman or a Member and immediately before his retirement was in receipt of pay or the pay fixed notionally is more than the amount specified above shall be entitled to draw the last pay drawn or entitled to get the pay fixed notionally, as the case may be".

No. 7670—GAD-FE-OSSC-0050/2017-Gen.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Staff Selection Commission Rules, 1993, namely :—

1. Short title and commencement—

(1) These rules may be called the Odisha Staff Selection Commission (Amendment) Rules, 2020.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Odisha Staff Selection Commission Rules, 1993 (hereinafter referred to as the said rules), for the words and expression "Group-B Civil Posts/Services with Grade Pay of Rs. 4,200 and all Group-C Civil Posts and Services" wherever they occur, the words, letters and figures "Group-B Civil Posts or Services carrying the Scales of Pay in the Level-9 of pay matrix under the Odisha Revised Scales of Pay Rules, 2017 and all Group-C Civil Posts and Services" shall be substituted.

3. In the said rules, in Rule 3, for sub-rule (3), the following sub-rule shall be substituted, namely :—

"(3) The Commission shall consist of a Chairman and three members to be appointed by the Government."

4. In the said rules, for Rule 5, the following rule shall be substituted, namely :—

"5. Requisition to the Commission—The competent authority as prescribed under the relevant recruitment rules shall communicate the number of vacancies to the Commission as per the administrative requirement subject to approvals as may be put in place by the Government from time to time, indicating the posts to be reserved for candidates belonging to different reserved categories."

5. In the said rules, for Rule 6, the following rule shall be inserted, namely :—

“6-A. Notwithstanding anything contained to the contrary in the relevant recruitment rules, no career assessment shall be made in the process of selection in respect of Group-B and Group-C posts and services”.

6. In the said rules, for Rule 14, after Clause (ii) the following proviso shall be inserted, namely :—

“Provided that no interview shall be conducted in the process of selection in respect of Group-C (Non-technical posts and services) except skill tests or physical test.”

7. In the said rules, in Rule 15, the sub-rule (4) shall be omitted.

8. In the said rules, in Rule 16, the sub-rule (3) shall be omitted.
