No.GAD-SER2-ID-0021-2018-28163/SCS. Pending finalization of the select list on the advice of the Odisha Public Service Commission, Shri Narendra Kumar Mantri, OAS (Supertime scale), Spl. LAO, Mahanadi Chitrotpala Irrigation Project (MCIP), Cuttack, who has been promoted to the rank of OAS (Supertime scale) vide GA & PG Department Notification No.7196/SCS dated 06.03.2019, is now allowed notional promotion to the said rank w.e.f. 02.05.2012 and to the rank of OAS (Superior Administrative Grade) w.e.f. 30.01.2017 on ad hoc basis for a period not exceeding one year or till receipt of recommendation of OPSC or till his retirement, whichever is earlier, without prejudice to the claim of others.

The inter-se Seniority of Shri Narendra Kumar Mantri is fixed above Shri Biranchi Narayan Mohanty and below Shri Manmath Kumar Biswal in the existing Gradation List of OAS (SAG) Officers. Shri Mantri shall not be entitled to any arrear financial benefit due to such notional promotion.

This promotion is subject to final orders of the Hon'ble Apex Court in SLP(C) No.35608-35610 (Gahadu Mirdha-Vs.- State of Odisha and others) and other related cases.

On promotion to the rank of OAS (SAG), Shri Mantri is transferred and posted as Secretary, State Information Commission, Odisha, Bhubaneswar.
