Shri Bharat Bhusan Jagadev, OAS-I (JB), Assistant Director (Administration) Office of the Survey & Map Publication, Orissa, Cuttack is notionally promoted w.e.f. 28th November, 2007 to the rank of OAS-I (Senior Branch) on adhoc basis carrying scale of pay in Pay Band-3 i.e. Rs.15,600 - 39,100/- with Grade Pay of Rs.6,600/- for a period not exceeding one year or till the recommendation of OPSC is received or until further orders, whichever is earlier without prejudice to the claim of others. But Sri Jagdev shall not be entitled to arrear financial benefits on account of his notional promotion to the rank of OAS-I (SB) for the period for which he has not actually worked in the rank of OAS-I (SB).

The Inter-se-seniority of Shri Bharat Bhusan Jagadev is provisionally fixed above Shri Mihir Chand Mallick and below Shri Sarat Chandra Mohapatra-1 in the rank of OAS-I (SB).

This promotion is subject to out come of OJC No.5922/2000 (Manmohan Mishra -vrs- State), OJC No.5921/2000 (Durga Prasad Behera -vrs- State), OJC No.7798/2000 (State -vrs- Gahadu Mirdha and others), pending in the Hon'ble High Court of Orissa and also subject to outcome of OA No.2177(C) of 2006 filed by Shri Khagendranath Jena and others -Vrs- State of Orissa and others.

On promotion, Sri Jagadev is posted as Deputy Director, Survey and Map Publication, Orissa, Cuttack against the existing vacancy. He is also allowed to remain in charge of Settlement Officer, Major Settlement, Cuttack in addition to his own duties.
