## OFFICE MEMORANDUM

Sub: Nomination of officers belonging to Non-State Civil Service for appointment to Indian Administrative Service of Odisha Cadre by selection.

As required under the provision contained in regulation 4 of the Indian Administrative Service (Appointment by Selection) Regulations, 1997, the State Government have declared thirty two (32) Non-State Civil Services (NSCSs) / posts in Class-II / Group-B, as in the schedule appended hereto, equivalent to the post of Deputy Collector in the rank of Class-II/Group-B in Odisha Administrative Service (OAS) vide .this Department Office Memorandum No.1148/AIS.I dated 11.01.2005, No.15145/AIS.I dated 31.07.2010 and No.10418/AIS.I dated 02.04.2014.

- 2. The State Government were considering the cases of the officers belonging to the so declared Non-State Civil Services / posts those who have completed not less than eight (8) years of service for appointment to IAS by selection.
- 3. The State Government have elevated the post of Deputy Collector in OAS to the rank of Class-I / Group-A vide this Department Resolution No.5719/Gen dated 28.02.2009.
- 4. Now, therefore, in consideration of the aforementioned facts & the provision contained in regulation-4 of the Indian Administrative Service (Appointment by Selection) Regulations, 1997 and in supersession of this Department Office Memoranda dated 11.01.2005, dated 31.07.2010 & dated 02.04.2014 referred above, the State Government have been pleased to declare the services / posts in the rank of Class-I / Group-A in the Non-State Civil Services referred above equivalent to the post of Deputy Collector in OAS and decide that the officers those who have completed not less than eight (8) years of service in the said NSCSs / posts in the rank of Class-I / Group-A shall be considered for appointment to IAS by Selection.

Provided that the State Government reserve the right to delete any of the above services or posts from the schedule or incorporate therein such of the services or posts equivalent to the post of Deputy Collector in Odisha Administrative Service:

Provided further that this Memorandum shall be applicable for the purpose of selection to the Indian Administrative Service only and not for any other purpose.

5. These orders shall come into force with effect from the date of issue of this Office Memorandum.
