RECL has consistently demonstrated outstanding performance and growth during its 48-year existence as one of the most profitable PSEs. During the 2016-17 financial year, RECL has sanctioned Rs 83,871 crores of loan for power projects and disbursed Rs 58,039 crores, registering a CAGR of around 25 per cent. It declared a profit after tax of Rs 6,246 crores, a growth of 11 per cent over the earlier year. RECL stock is traded on BSE and NSE, which has appreciated more than 76 per cent over the past six months. The Company has pan-India presence with twenty regional offices that work closely with the Central and State power sector utilities, private power producers, renewable energy promoters, and entrepreneurs.

In addition, and more importantly, REC is the Nodal Agency for several flagship programmes of Government of India that include *inter alia*, 'Deen Dayal Upadhyaya Gram Jyoti Yojana' (DDUGJY), Ujjwal Discom Assurance Yojana (UDAY), 'National Electricity Fund' (NEF), monitoring the 'Outage Management System' and '11-KV Rural Feeder Management System', besides acting as the 'Bid Process Coordinator' for selection of Developer through Tariff Based Competitive Bidding process for establishment of Inter-State Transmission Systems through Public-Private-Participation.

Further, REC has two fully owned subsidiaries, REC-TPCL and REC-PDCL, that provide high value services, including project design, implementation, monitoring and evaluation services, bid processing, contract management, capacity development, knowledge management, etc. Both subsidiaries have been growing at a rapid pace and have the potential to achieve annual revenues of One thousand crores each. The ED would also function as the CEO of one of the subsidiaries. For several years, REC has had two IAS officers working as Executive Directors, duly supporting the Managing Director in effective management of the REC core business, government flagship programs and the subsidiaries.

It is proposed to fill up the post of First Secretary (Legal), Permanent Mission of India (PMI), WTO, Geneva for a period of three years. The post is at Deputy Secretary/Director level.

The mandatory and desirable qualifications for the post are as under :

(A) Mandatory Qualifications

- (i) The officer must have worked for at least 2 years at the Centre under the Central Staffing Scheme.
- (ii) The officer should have experience in trade, commerce, industry and allied sectors either at the Centre or in the State Government/Cadre.
- (iii) The officer should have a degree in Law (LL.B.).
- (iv) The officer should be clear from vigilance angle.
- (v) The officer should not have been debarred from Central deputation.
- (vi) The officer should have at least 'Very Good' Service record. However, preference will be given to officers who have 'Outstanding' service record.
- (vii) The officer should not be over 54 years of age.
- (viii) The officer should not have been posted on an assignment in a foreign/captive post of Government of India, earlier.
- (ix) The officer should not have been nominated for foreign training or should not be on training or foreign assignment, currently.
- (x) The officer should not be on study leave or long leave.
- (xi) The officer should be at least one batch below the batch of officers who are currently empanelled to hold the post of joint Secretary or its equivalent with the Central Government.

(B) **Desirable Qualifications**

- (i) Exposure to international negotiations in trade, commerce, industry and allied sectors.
- (ii) Work experience on legal documents and treaties.

3. This post may be circulated amongst officers eligible to be appointed at the level of Deputy Secretary/Director in the Government of India. Names of willing and eligible officers who can be spared by the State Governments/Ministries/Departments may be forwarded/ faxed to this Department along-with **Cadre clearance, Vigilance clearance, detailed Bio-data and ACR Dossier/certified ACR gradings for the last five years**. It may also be ensured that the "Cooling Off", after a previous stint on deputation, if any, is complete and the officer is eligible to be appointed on Central Deputation.
