Sub: Recommendation of Non-State Civil Service Officers for their consideration for appointment to IAS of Odisha Cadre by selection during 2018 against the Select List - 2017.

Sir/Madam,

I am directed to say that in accordance with the provisions contained in sub-rule (2) of rule 8 of the IAS (Recruitment) Rules, 1954, the State Government from time to time consider the cases of persons not belonging to the State Civil Service, but serving in connection with the affairs of the State for appointment to IAS by selection. One (1) vacancy in the promotional quota meant for NSCS officer has been assessed provisionally for the Select List -2017 which shall be filled up from among the suitable and willing NSCS officers during 2018.

The eligibility criteria of the officers are as follows:-

(a) The officers should be of outstanding merit and ability;

(b) They should have completed not less than eight(8) years of continuous service under the State Government as on the first day of January, 2017 in a Group-A post which has been declared equivalent to the post of Deputy Collector in the state civil service and have held that post in a substantive capacity and confirmed as on 01.01.2017;

(c) They should not have attained the age of 56 years on the 1st day of Jan. 2017;

(d) The officers should be free from disciplinary proceedings / criminal cases / vigilance cases etc.

You are, therefore, requested to kindly recommend the name of not more than three eligible and willing NSCS officers working in and under your Department and furnish their service particulars in the enclosed proforma with relevant documents and their willingness duly authenticated by a competent authority to this Department within 20 days from the date of issue of this letter for their consideration for appointment to IAS by selection during 2018. This may be noted that since the last batch of officers selected under NSCS are likely to be allotted to the year 2012, comparatively younger officers having requisite qualification and willing for selection to IAS may be nominated for the purpose.
