Department Office Order No.7248 dtd.01.05.2015, Shri Bijay Kumar Rath, OAS-A (JB), Additional Sub-Collector, Balasore is notionally promoted to the grade of OAS-A (SB) on adhoc basis carrying pay band-3 in the scale of pay of Rs.15,600 – 39,100/- + Grade Pay Rs.6,600/- P.M. w.e.f. 29.07.2011 i.e. the date of promotion of his junior Shri Bhumesch Chandra Behera to the above grade for a period not exceeding one year or till receipt of recommendation of OPSC or till his retirement, whichever is earlier without prejudice to the claim of others.

This promotion is subject to outcome of SLP(Civil) appeal No.8498/ 2010 and Civil Appeal No.3240/2011 filed by Shri Pravakar Mallick and others –vrs-State of Odisha and others and also the final orders of the Apex Court in SLP ( C) No.35608-35610 of 2010 (Gahadu Mirdha –vrs- State of Odisha and others) and other related cases.

His inter-se-seniority is fixed below Shri Rajendra Mishra and above Shri Bhumesch Chandra Behera in the grade of OAS-A (SB).

Shri Rath will get no financial benefit due to this notional promotion. His pay will be notionally fixed w.e.f. 29.07.2011 i.e. the date of promotion of his junior.
