No. **GAD-SER2-ID-0023-2021-21900/SCS**. Pending finalization of the select list on the advice of the Odisha Public Service Commission, Shri Prabeer Kumar Nayak, Additional District Magistrate, Jharsuguda, who has already been promoted to the grades of OAS (Supertime scale) and OAS (Superior Administrative Grade) vide the GA & PG Department Notification No.7196/SCS dated 06.03.2019 and the GA & PG Department Notification No.2002/SCS dated 25.01.2022 respectively, is now allowed notional promotion to the said grade of OAS (Supertime scale) w.e.f. 19.04.2018 and to the grade of OAS (Superior Administrative Grade) w.e.f. 25.06.2021, at par with his junior Shri Subhananda Mohapatra, on ad hoc basis for a period not exceeding one year or till receipt of recommendation of OPSC or till his retirement, whichever is earlier, without prejudice to the claim of others.

Shri Nayak shall not be entitled to any arrear financial benefit due to such notional promotion.

On promotion to the Grade of OAS (SAG), the inter-se seniority of Shri Prabeer Kumar Nayak is fixed above Shri Subhananda Mohapatra and below Smt. Sucharita Sarangi in the existing disposition list of OAS (SAG) Officers.

This promotion is subject to final orders of the Hon'ble Apex Court in SLP(C) No.35608-35610 (Gahadu Mirdha-Vs.-State of Odisha and others) and other related cases.
