Kumar & Ors. – vrs – State of Odisha & Ors.): - "The promotion given from OAS Group-A(JB) to OAS-Group A(SB) during pendency of the matter will not confer any equity in favour of any of Promotees and that will be subject to the final outcome of all the writ Petitions to be heard analogously by this Court."

This promotion is also subject to the final outcome / decision in the SLP (Civil) Appeal No.8490 of 2010 and Civil Appeal No.3240 of 2010 (filed by Shri Pravakar Mallick and others -vrs- State of Odisha & others) and other related cases, if any, pending in the Court of law.
