Bhubaneswar, dated the **28th February, 2022**

No.**GAD-SER2-CASE1-0004-2022-5677/SCS**. Pending finalization of the select list on the advice of the Odisha Public Service Commission, keeping in view the order dated 08.02.2022 passed by the Hon'ble High Court of Orissa in W.P.(C) No.3843 of 2022, Shri Raj Kishore Sashtri, OAS Gr.A (Junior Branch), Under Secretary to the RDC (CD), Cuttack, is allowed notional promotion to the higher grades of the Odisha Administrative Service cadre at par with his junior Shri Asit Kumar Panda with effect from the dates mentioned below.

1. From the grade of OAS Gr.A (Junior Branch) to OAS Gr.A (Senior Branch) notionally with effect from 30.10.2014.
2. From the grade of OAS Gr.A (Senior Branch) to OAS (Supertime scale) notionally with effect from 30.12.2017.
3. From the grade of OAS (Supertime scale) to OAS (Superior Administrative Grade) notionally with effect from 25.06.2021.

Such notional promotion of Shri Raj Kishore Sashtri to the said higher grades of the OAS Cadre is made against the supernumerary / temporary posts created vide the GA & PG Department Order No.5674/SCS dated 28.02.2022.

Such notional promotions are being allowed on ad hoc basis for a period not exceeding one year or till receipt of recommendation of OPSC or till his retirement, whichever is earlier, without prejudice to the claim of others.

On notional promotion to the Grade of OAS (SAG), Shri Sashtri is allowed to continue in his present place of posting. Shri Sashtri shall not be entitled / eligible to avail the arrear financial benefits due to such notional promotion.

On notional promotion to the Grade of OAS (SAG), the inter-se seniority of Shri Raj Kishore Sashtri is fixed below Shri Sudhakar Sabaro and above Shri Gyanaranjan Bhanjadeo in the existing disposition list of OAS (SAG) Officers.

This promotion is subject to final orders of the Hon'ble Apex Court in SLP(C) No.35608-35610 (Gahadu Mirdha-Vrs-State of Odisha and others) and other related cases.
