Dear Chief Secretary,

National Dairy Development Board (NDDB) is a statutory body set up by an Act of Parliament (NDDB Act of 1987) with its headquarters at Anand, Gujarat mandated to promote, plan and organize programmes for development of dairy and other agriculture/allied industries and biologicals on nation-wide basis and to render assistance in implementation of such programmes through the cooperative strategy.

2. Its achievements in Operation Flood during 1970-1996 changed the lives of millions of milk producers in the country under the leadership of eminent Dairyman of India, Padma Vibhusan Dr. V. Kurian. Presently, these initiatives are being carried forward with ambitious projects such as Dairy Infrastructure Development Fund (DIDF) and Supporting Dairy Cooperatives & Farmer Producer Organisations (SDC&FPO) for creation & enhancement of milk processing infrastructure and provide marketing facilities to dairy farmers and achieve a milk production of 220 million tonnes by the end of year 2022.

3. NDDB as an organisation is led by the Chairman deriving powers from the NDDB Act, 1987. The Department of Animal Husbandry and Dairying is in the process of filling up the post of chairman, NDDB. The post of Chairman, NDDB falls under Pay Level 17 [Rs. 2,25,000/ (Fixed)] as per recommendations of 7<sup>th</sup> Pay Commission. Accordingly, a Search-cum-Selection Committee has been constituted under the Chairmanship of Cabinet Secretary with eminent experts to recommend suitable candidates for the post of Chairman, NDDB for approval of the Competent Authority. This is to request you to kindly suggest name(s) of suitable person(s) of pre-eminence with exceptional leadership quality, integrity as well as being professionally qualified in one or more specialities, namely Dairying, Animal Husbandry, Rural Economics, Rural Development, Business Administration or Banking, for the post of Chairman, NDDB.

4. I urge your personal attention in the matter and would request that the name(s) of such most appropriate candidate(s) with detailed Curriculum Vitae may kindly be sent within four weeks latest by 15.02.2021 by email jsdairy-ahd@nic.in or by post to Joint Secretary, (CDD), Room No. 240, Krishi Bhawan, New Delhi - 110001.
