Bhubaneswar, dated the 30th November, 2019

No.PT1-GAD-SER1-PERS-0029-2014-34570/AIS.I WHEREAS, **Dr. Gagan Kumar Dhal**, IAS (RR-1985), Chairman, Odisha Forest Development Corporation Ltd., Bhubaneswar drawing Pay Rs. 2,25,000/-in the Level-17 in the Pay Matrix of IAS (Pay) Rules, 2016 read with IAS (Pay) Amendment Rules, 2017 has applied for voluntary retirement from the Indian Administrative Service with effect from 30.11.2019 vide his representation dated 27.11.2019 on personal grounds by relaxing the mandatory notice period of 3 months as provided under rule 16(2) of AIS (DCRB) Rules, 1958.

AND WHEREAS, Sub-Rule (2) of Rule 16 of AIS (DCRB) Rules, 1958 provides that a Member of the Service may after giving at least 3 (three) months' previous notice in writing to the State Government, retire from service on the date on which such member completes 30 (thirty) years of qualifying service or attains 50 (fifty) years of age or on any date thereafter to be specified in the notice;

AND WHEREAS, the date of birth and date of entry into Government Service of Dr. Gagan Kumar Dhal, IAS being 05.01.1960 [Fifth January Nineteen Sixty] and 26.08.1985 [Twenty Sixth August Nineteen Eighty Five] respectively. Dr. Gagan Kumar Dhal, IAS has completed 30 years of qualifying service as on 25.08.2015 and has attained 50 years of age as on 04.01.2010 as required and is therefore eligible to retire from Government service voluntarily under Sub-Rule (2) of Rule 16 of AIS (DCRB) Rules, 1958;

AND WHEREAS, the State Government is empowered under Rule 16(2) of AIS (DCRB) Rules, 1958 to accept the application for voluntary retirement of the IAS officers belonging to the State cadre and under the second proviso to Sub-Rule (2) of Rule 16 of AIS (DCRB) Rules, 1958 inserted in AIS (DCRB) Amendment Rules, 2004 [vide GSR No.820 (E) dtd.15.12.2004 of Government of India, Ministry of Personnel, Public Grievances & Pensions, New Delhi] to relax the mandatory period of 3 (three) months previous notice on a request made by the Member of the Service, and for reasons to be recorded in writing;

AND WHEREAS, in exercise of the powers conferred on them under AIS (DCRB) Amendment Rules, 2004 [vide GSR No.820 (E) dtd.15.12.2004] the State Government have been pleased to relax the mandatory notice period of three months in case of Dr. Gagan Kumar Dhal, IAS for his voluntary retirement from service on being satisfied about the reasons for relaxing such notice period on personal grounds.

NOW THEREFORE, **Dr. Gagan Kumar Dhal, IAS** at present Chairman, Odisha Forest Development Corporation Ltd., Bhubaneswar is allowed to retire voluntarily from the Indian Administrative Service **w.e.f 30.11.2019 (FN)** under Sub-Rule (2) of Rule 16 of AIS (DCRB) Rules, 1958 read with AIS (DCRB) Amendment Rules, 2004. Consequent upon his voluntary retirement he will be entitled to all retirement benefits as per rules under AIS (DCRB) Rules, 1958.
