Pending finalization of the select list on the advice of the Odisha Public Service Commission, Shri Pratap Chandra Rout, Joint Secretary, Odisha Staff Selection Commission, Bhubaneswar who has already been promoted to the rank of OAS (Supertime scale) vide GA & PG Department Notification No.7196/SCS dated 06.03.2019, is now allowed notional promotion to the Grade of OAS (Supertime scale) w.e.f. 02.05.2012 and to the Grade of OAS (Superior Administrative Grade) w.e.f. 30.01.2017, on ad hoc basis for a period not exceeding one year or till receipt of recommendation of OPSC or till their retirement, whichever is earlier, without prejudice to the claim of others.

This promotion is subject to final orders of the Hon'ble Apex Court in SLP(C) No.35608-35610 (Gahadu Mirdha-Vrs-State of Odisha and others) and other related cases.
