Pending finalization of the select list on the advice of the Odisha Public Service Commission, Shri Sahadev Samadhia, OAS Gr.A (Senior Branch), Registrar, North Odisha University, Balasore, who has already been promoted to the Grade of OAS Gr.A (SB) vide GA & PG Department Notification No.7200/SCS dated 06.03.2019, is now allowed notional promotion to the said Grade w.e.f. 30.10.2014 on ad hoc basis for a period not exceeding one year or till receipt of recommendation of OPSC or till their retirement, whichever is earlier, without prejudice to the claim of others.
