The order of detailed place of posting shall be issued on 07th December, 2023 following the Counselling Session for exercising the option of first place of posting by the candidate.

The service of candidates are subject to the following terms and conditions:


1. The Counselling session of the selected candidates shall be held at SCSTRTI, Unit-VIII, CRP Square, Nayapalli, Bhubaneswar-03 on **07th December, 2023** as per the Resolution no. 14327/Gen dated. 04.07.2017 of the G.A. & P.G. Department.
2. The candidates are directed to report at the venue of counselling at 11:30 a.m. on the above mentioned date with the following documents:
 - a. Offer of Appointment.
 - b. OPSC Admit Card for appearing Prelim / Mains / Document Verification.
 - c. Identity Card issued by Government :- Driving License or Voter Identity Card or
 - d. Aadhaar Card or Passport etc..
3. The appointment is subject to the character and antecedent found satisfactory after verification. In case, any adverse report is received, the candidates concerned shall be terminated from service in accordance with the provisions laid down in sub clause (ii) of clause (h) of Explanation under rule – 13 of Odisha Civil Services (Classification, Control and Appeal) Rules, 1992 reinforced in G.A. Department Resolution No. 34438/Gen, dated: 20.11.1999.
4. In case of PWD candidate, the appointment is subject to verification / clearance as per Resolution No. 1843 dated. 25.02.2021 & Notification No. 9789 dated: 21.12.2021 of the SSEPD Department.
5. The candidates are instructed to join at their respective place of posting on or before 05th January, 2024 failing which the appointment shall be automatically cancelled.




