Bhubaneswar dated the 28th NOV , 2023

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Civil Services (Combined Competitive Recruitment Examination) Rules, 1991, namely:—

1. Short title and commencement.— (1) These rules may be called the Odisha Civil Services (Combined Competitive Recruitment Examination) Amendment Rules, 2023.

(2) They shall come into force on the date of their publication in the Odisha Gazette.

2. In the Odisha Civil Services (Combined Competitive Recruitment Examination) Rules, 1991, in SCHEDULE-I, after serial No. 11, the following serial numbers along with its entries shall be inserted under the appropriate columns, namely:—

"12. Tourism Development Officer, The Odisha Tourism Service The Odisha Tourism Service (Methods of Recruitment and Conditions of Service) Rules, 2023.

13. Assistant Auditor General of Cooperative Societies, Level-II, Group-B The Odisha Co-operative Audit Service (Method of Recruitment and Conditions of Service) Rules, 2022."


