Subject: - Restructuring of the District Revenue Ministerial Cadre.


Pursuant to creation of a separate District Revenue Ministerial Service Cadre, Government have been pleased to decide that :

- a. District Level Revenue ministerial employees working in the Collectorate, Sub Collector Offices, Tahasils and also working in offices like RTO, CSO, ICDS, Blocks , ITDA etc shall, taken together, constitute a separate cadre namely District Revenue Ministerial Service Cadre.
- b. Separate Cadre Rules with service conditions shall be framed for them with required levels of promotional posts taking into consideration the administrative requirements.

This will come into effect from the date of issue of this Resolution.
