**NOTIFICATION**

Bhubaneswar Dated the 10<sup>th</sup> Jan., 2024

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Civil Service (Fixation of Upper Age Limit) Rules, 1989, namely:-

1. Short title and commencement.— (1) These rules may be called the Odisha Civil Service (Fixation of Upper Age Limit) Amendment Rules, 2023.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Odisha Civil Service (Fixation of Upper Age Limit) Rules, 1989, in rule 2, for the second proviso, the following proviso shall be substituted, namely:—

“Provided further that for advertisements made during calendar years 2021, 2022, 2023 and 2024 the said upper age limit shall be thirty-eight years;”
