No. **GAD-SER2-ID-0001-2024-13586/SCS**. Pending finalization of the select list on the advice of the Odisha Public Service Commission, Sri Nabin Chandra Naik, Additional District Magistrate, Nabarangpur, who has already been promoted to the grade of OAS (Supertime scale), is now allowed notional promotion to the different grades of the OAS cadre as mentioned in the following table, on ad hoc basis, in different levels of the "Pay Matrix" as specified in the First Schedule of the O.R.S.P. Rules, 2017, for a period not exceeding one year or till receipt of recommendation of OPSC or till his retirement, whichever is earlier, without prejudice to the claim of others.

On notional promotion to the Grade of OAS (SAG), Sri Naik is allowed to continue in his present place of posting until further orders.

Sri Naik shall not be entitled to any arrear financial benefits due to such notional promotions to the different grades of the OAS cadre.

On such notional promotion to the Grade of OAS (SAG), the inter-se-seniority of Sri Naik is fixed immediately above Sri Rameswar Pradhan in the said grade of OAS (SAG).

This promotion is subject to final orders of the Hon'ble Apex Court in SLP(C) No.35608-35610 of 2010 (Gahadu Mirdha-Vs.-State of Odisha and others) and other related cases.
